WHEREAS Enugu State Local Government Council Elections are due to be held in 2026,

AND WHEREAS the Enugu State Independent Electoral Commission (ENSIEC) is empowered by the Enugu State Electoral Law and other relevant statutes to organize, undertake and supervise all elections to the Local Government Councils within Enugu State;
